Dist. No. 1

Beginning at Jonathan Lutton's at the northern  
meeting house. Thence South with the Upper  
Road so as to take in Daniel White's farm  
Thence South to Benjamin Martin's Thence  
with the Road to Samuel Shannon's on  
the Clifton & Lexington Road Thence West to the  
Boliver Road to Stenman's creek to the corner of  
No. 10. Thence with the old county line to the  
corner of No. 4 & Thence with said line to the  
Beginning at M'Kisada Meeting house

Dist. No. 2

Beginning at the mouth of White's creek Thence with  
the line of No. 3. to M'Kisada meeting house Thence  
South to Benjamin Martin's Thence with the Road  
to Samuel Shannon's to Lumbo's creek Thence with  
said creek to the mouth Thence down Sun-  
River to the mouth of White's creek to the Beginning

Dist. No. 3

Beginning at the mouth of Beech River Thence up  
said River to the mouth of Rushing's creek  
Thence up said creek to Patten's Mill seat Thence  
South so as to include William Henry's old Residence  
Thence South so as to include John Esay's Residence  
Thence down a Branch to White's creek Thence  
down said creek to Benson River Thence down said  
River to the Beginning

Dist. No. 4

Beginning at the mouth of Rushing's creek Thence up  
said creek to the old Patten's Mill seat Thence with  
the line of No. 3. to the old bottom ferry Road  
at Jonathan Lutton's Thence West with the said Road  
to Rushing's creek Thence up said creek to the old county  
line Thence North with said line to the Denton Hill Road  
Thence West with the Scott's Hill Road to the fork of  
said Road Thence with the old Lexington Road to the  
Henderson county line Thence with said line to Beech  
River Thence down said River to the Beginning

District No 5

Beginning at the mouth of Cubbrook. Thence up said creek with the line of Dist. No. 9. To Wilkins shop Thence North with the Ridge between Joseph Collins & James McMurrye to the Haman ford on Cubbrook Thence North to the little creek that Henry Boman lives on. Thence up said creek to the Road leading from McIlwaine's Mill to Levin Gary's. Thence North with said Road to the 5 mile Post on the Maple Spring Road. Thence North including S.W. Smith's Land & Residence in the 5 Dist. to the Lodge School house. Thence N.E. to the Camden Road. Thence N.E. to J. E. Conrad. including the Land's & Residence of J. J. Conrad, B. E. Williams & Phillips Conrads in the 5 Dist. Thence with the old Bandy ferry Road to the Tenn. River near the head of Devison's Island. Thence up said River to the Beginning.

District No. 6

Beginning at the Beech River Bridge where the Road leading from Decaturville to Camden crosses the said River. Thence up said River to the Henderson County line. Thence North with said line to the Exchange Road. Thence East with said Road to G. W. Wilkins shop Thence South with the Road leading from Decaturville to Camden to the Beginning.

District No. 7

Beginning at the mouth Beech River, Thence up Beech River to the Stone Pillar Bridge where the Road leading from Decaturville to Camden crosses the same. Thence North with said Road to the Exchange Road to G. W. Wilkins's Shop Thence E. with the Exchange Road N. to the Little Creek at J. W. Jennings's residence Thence down said Creek to Cub Creek. Excluding W. L. Lewis Land & Residence, the same being <sup>Excluded by</sup> and Dist. (No. 5). Thence down Cub Creek to Tenn. River. Thence up Tenn. River to the Beginning.

District No. 8.

Beginning on the Maple Spring Road where the line of the 5<sup>th</sup> District crosses the same Thence N. with said Road to the Henderson County line Thence N. with the Henderson County line to the Benton County line Thence East with said line to the Camden Road. N. of S. E. Spencer's Thence South with said Road to the line of the 5<sup>th</sup> District. Thence with said line to the Beginning.

District No 9;

Beginning on the Tennessee River where the line of the 5<sup>th</sup> District strikes the same near the head of Demond Island thence W. with the line of the 5<sup>th</sup> Dist. to the Camden Road, thence North with said road, on by C. P. Spence to the Benton County line thence E. with said line to the Tennessee River thence up said River to the Beginning.

District No 10

Beginning at John Lockheart with the Henderson County line South to old Bolivar Road thence with Bolivar Road, to the Slave Road leading by Martin Holland, on Doe Creek, at the fork of said C. R. thence with the old County line to Becking's Creek thence with the line of District No. 11 to the Beginning.

District No 11

Beginning at the mouth of Turnbow Creek thence W. up said Creek to the Clifton & Lexington Road to the fork of the road leading to Bolivar, thence with the Bolivar road to Turnbow Creek to the fork of said Creek, thence South with the Slave road to Doe Creek thence down Turnbow River thence down said river to Turnbough Creek to the Beginning.

District No 12

Beginning where the Decaturville & Camden Road crosses the Exchange Road. Thence W. with the old Exchange Road to the Henderson County line. Thence North with said line to the Maple Spring Road. Thence E. with said road to the 6 mile post where the line of the 5<sup>th</sup> Dist. crosses the same including the Land & Residence of E. P. Harris & W. R. Harris in the 12 Dist. Thence south with the line of the 5<sup>th</sup> Dist. to the Beginning.

Court then adjourned until Wednesday morning 9 o'clock.
