

DEED

THIS INDENTURE made this 14th day of October, A.D., 1955, between the UNITED STATES OF AMERICA, Grantor, acting herein by and through ^{Assistant} Secretary of Agriculture, hereunto duly authorized by Subsection (c), Section 32, Title III, Bankhead-Jones Farm Tenant Act (50 Stat. 522, 525), as amended July 28, 1948 (56 Stat. 725), the provisions of which have been complied with, and the State of Tennessee, Grantee,

WITNESSETH, That the Grantor, in consideration of the premises and the sum of one dollar, the receipt of which is hereby acknowledged, does by these presents grant, release, remise and forever quitclaim unto the said Grantee, its successors and assigns, all those tracts or parcels of land embraced within the Natchez Trace Project TN-LU-6, lying and being in the Counties of Benton, Carroll, Decatur and Henderson, State of Tennessee, and more particularly described in the deeds and judgments listed below by which the Grantor acquired title thereto; reference being made to the place of recording in the Office of the Register of Deeds of Benton, Carroll, Decatur and Henderson, Tennessee, cited below, for full and complete descriptions thereof and to the records of the Clerk of the United States District Court for the Western District of Tennessee, which by reference are incorporated in this conveyance to the extent as if the descriptions were fully set forth herein:

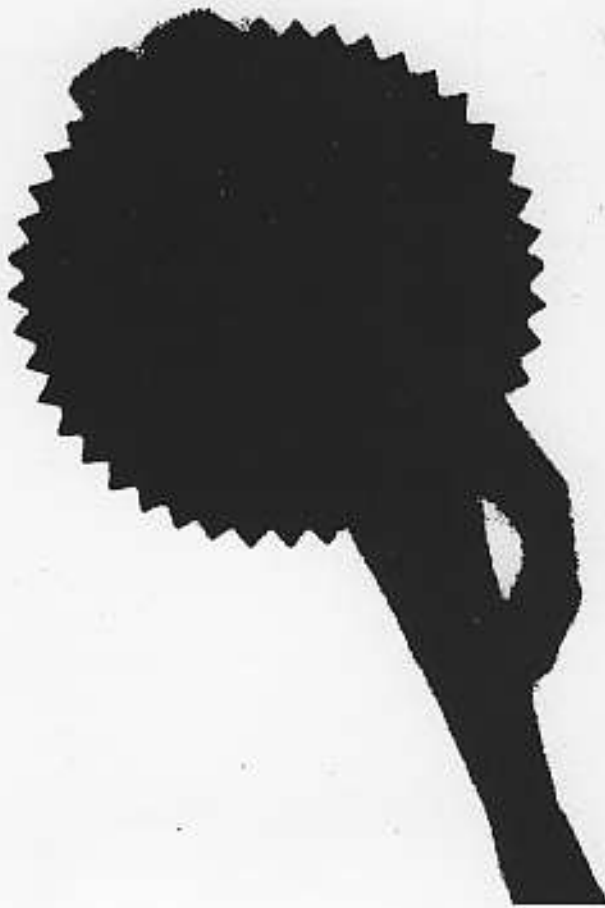
